If the personal information you provide is incomplete or inaccurate, we may not be able to provide you with the products or services you seek.

We may disclose personal information about you to our related entities and other organisations with whom we have affiliations with, physiotherapists and other medical professionals, relevant sporting clubs or associations and service providers who assist us operating our business. We are not likely to disclose your personal information overseas, unless a user accesses the service from overseas, in which case your personal information would be transferred overseas.
